

## **MODEL RELEASE FORM - (must be completed and returned)**

I agree to be filmed/videotaped and or photographed in conjunction with Fun Events subsidiaries, successors, licensees, and assignees may copyright, use, and reuse, publish, distribute, edit, excerpt and otherwise exploit my name (real or fictional), likeness, persona, performance, voice, picture, chat, video, audio, biological information and identification, and statements, (collectively my "appearance") for any and all uses, in whole or in part, in any limitation, including in conjunction with the advertising, exploitation and publicizing of Fun Events and its affiliates. I understand that Fun Events is proceeding upon the terms set forth herein, and I will not intend to revoke this release at any time.

This agreement shall be governed exclusively under English law and exclusive jurisdiction shall be in London, UK.
